Once the deadline has been selected, the investor can no longer unstake their BitBankCoin coins before the staking period has expired.



2. Eligibility Criteria for Bank Loans

Any investor who has met the above-listed conditions is a potential candidate for the staking program with bank loans. To be accepted for a loan, the investor cannot request more than double the value of their staked tokens at the time of the loan request.

The investor must familiarize themselves with the applicable regulations regarding cryptography in their country.

Application processing time: Loan applications are processed in less than 24 hours, Monday to Friday, 8 AM to 5 PM GMT.



## RELINQUISHMENT OF OWNERSHIP IN CASE OF NON-FULFILMENT OF COMMITMENTS






These tokens become the exclusive property of LoanCEX.




### TRANSACTION GATEWAYS FOR LOANS










The investor wishing to take out a loan is free to choose the gateway that best suits them.



### LOAN REPAYMENT TERMS



The stakeholder who has taken out the loan has a two-month grace period to begin repaying the loan. Loan repayment begins on the tenth day of the third month following the signing of the loan agreement. Let's take the example of a \$500 loan finalized on August 5, 2025. The repayment is as follows:


